



## Construction Newsletter

### July 20, 2018

The City received construction bids for the 2018 Street and Utility Improvement project this spring, which included the rehabilitation of Jackson/Old C/Lake Shore by mill and overlay along with spot curb and gutter repair. The work also includes inspection and maintenance work on the existing watermain. The Contractor that was awarded the project was Hardrives, Inc. and they have provided a schedule to begin work on Jackson/Old C/Lake Shore the week of July 30<sup>th</sup>.

### Schedule

The first work to be completed on the street will be the inspection and maintenance work on the existing watermain. This will require spot excavations in and along the roadway at designated valve and fitting locations. The only impacts to traffic during this first stage of work will be directly adjacent to the excavations. The Contractor anticipates 6 days of underground watermain work; however this could be extended if working conditions are difficult or if additional watermain fittings are excavated due to the conditions of those initially inspected. The watermain work will be followed by street milling and curb and gutter removal and replacement. More specific schedule information will be provided for that work in future newsletters.

### Watermain Service Impacts

As noted above some of the watermain inspections and maintenance will be on existing mainline watermain valves. Replacement of valve bolts can be done with the watermain in service, however we do anticipate that some of the valves will need full replacement, and that will require shutting off the watermain. The City will provide notice of any watermain shutdown to the residents that are affected the day before the shutdown will occur. The watermain will be shut down during construction hours and turned back on at the end of the day. The watermain will likely need to be shut down several times, but water service will be restored at the end of each day before the Contractor ends work for the day.

### Other Information

The Contractor will be responsible for maintaining garbage and mail service throughout the project. The postmaster will determine if temporary mailboxes will be used and where they will be located but we anticipate mail service to be to your normal mailboxes throughout the project. The Contractor will provide notices to each residence if/when temporary boxes are going to be used. Garbage service will be maintained to your driveway or the Contractor will bring your garbage outside of the project, have it dumped, and return your container to your driveway.

We ask that you notify our office or our inspector of existing underground dog fences and irrigation systems so we can notify the Contractor. Please contact the project inspector Lyle Splittstoser or City Engineer Lee Elfering at the numbers at the end of this newsletter.
